

Impact of Mo-Dad Utilities Sale

Many of you may have already heard that Mo-Dad **Utilities** has been sold to Magnolia Utilities, a much larger company. The Carter Plantation Community Development District (CP CDD) has a contract with Mo-Dad **Maintenance**, a separate company, to operate the water and sewer systems here at Carter Plantation. Mo-Dad **Maintenance** was **NOT** part of the sale to Magnolia, even though ownership and management of Mo-Dad **Maintenance** has changed.
