

The Carter Plantation Community Association (Property Owners) Annual Membership Meeting will be held Thursday, January 14, 2021, at 6 PM in the Clubhouse. March 1, 2021 LATE PENALTY — \$85 plus \$8.50/month charge

March 31, 2021 — Liens will be issued, at the Board's discretion, for lots that have not paid their dues in full.
