Homes under construction or being designed by a home owner:

- **Twenty homeowners have started construction or are in review process:**

 - Antisan on lot 165 (exterior complete, finishing interior)
 - Sale on lot 126 (landscaping)
 - LeBlanc on lot 118 (finishing exterior)
 - Nagim on lot 120 (finishing exterior)
 - Sunrise Homes on lots 228 & 229 – (framing complete, finishing exterior)
 - Perde on lot 162 (slab poured, framing started)
 - Mindrut on lot 104 (slab being formed)
 - Gedusa on lot 208 (slab formed)
 - Castjohn on lot 160 (lot cleared; pad built)
 - Lambert on lot 19 (lot cleared; pad built)

 - Easley on lot 18 (lot cleared; plan approved, construction ready to start)
 - Tantillo on lot 49 (lot cleared; plan approved, construction ready to start)
 - Arion/Hecht on lots 105 & 109 (plan approved, need to finalize site plan)

 - Bacile on lot 2B (back yard pool near complete)
 - Nunez on lot 169 (back porch near complete)
 - Brister on lot 234 (roof over back porch)
- **Lot 179 – Peter Chan;** reviewed preliminary plans; final not submitted; trees removed, lot cleared
- **Lot 158/9 – Hinostroza** (application submitted, fees paid, no plans yet)
- **Lot 184 – Kingston;** reviewed preliminary plans; not yet submitted (Monarch Point)
- **Lot 277 – Cummer,** asking permission to build treehouse. Plan submitted, under review.
- **Lot 236 – Bailey** building outdoor kitchen on existing back patio
- **Lot CC5 - Perrin** submitted preliminary plans, no application or fees

Other development:

- **River Lot Covenants generated w/ B.Waters** – Bulkhead & piling construction started with steel beam framing on six lots. Framing started on two.
- **Carter Reserve** - Two houses near completion; one house being framed and one plan approved
- **ARB** to meet and discuss policy regarding post hurricane tree replacement.

Lots owned/developed by Level Homes (70 lots)

- Completed 54 homes finished or occupied in since 2018.
- Have ten homes in construction or plans submitted & ready to start.
 - 40 & 59 – Near completion finishing interior
 - 62, 262, 37 & 7A – framed, starting to work on exterior
 - 261 & 3A – Just starting; slabs poured
 - 219 & 11A – Plans approved; not started
- 6 Un-developed lots: 1 in The Glade; 3 in Tall Timbers; 2 on Cemetery Rd.
- In negotiation with owner to purchase nine lots in Tall Timbers
